Community Air Monitoring Program April 27, 2009 through May 1, 2009

Community air monitoring data is reviewed and compared to specific NYSDEC/NYSDOH approved criteria, known as "Action Limits". As a result of this evaluation process, site conditions are categorized into two categories, "Operational Condition" and "Action Condition". The "Operational Condition" is applicable when the data is below the "Action Limits" noted in the table below. The "Action Condition" occurs when one or more fifteen minute average measurement for Dust (PM<sub>10</sub>), Total Volatile Organic Compounds (TVOC), Naphthalene or Odor Intensity exceeds the background or upwind measurement by the "Action Limits" in the table below. During the period from April 27, 2009 12:00AM through ~11:00AM there were six Fixed Air Monitoring (FAM) locations measuring Total Volatile Organic Compounds (TVOC) and Particulate Matter (PM<sub>10</sub>). During the period between April 27, 2009 and May 1, 2009 there were three Portable Air Monitoring (PAM) locations measuring TVOC and PM<sub>10</sub> during normal work hours. The completion of ground intrusive or impacted soil activities at the Sag Harbor remediation site prompted the site activities to transition into the demobilization phase air monitoring for TVOC and PM<sub>10</sub> was reduced from six FAM locations to three PAM locations. **Fifteen-minute averages for odor intensity, naphthalene, TVOC, and PM<sub>10</sub> data remained in Operational Condition**.

On Tuesday, April 28, 2009 there were periods of elevated concentrations of dust for two minutes at PAM-1. These elevated concentrations of dust were caused by wind blown dust. Watering was conducted onsite routinely throughout the day but gusty winds, low relative humidity and unseasonably warm temperatures caused unusually dry conditions onsite. This dust was not associated with ground intrusive or impacted soil activities; therefore the site conditions remained at the operational condition (less than the Action Limit).

On Friday, May 1, 2008 there were periods of elevated concentrations of dust for thirteen minutes at PAM-3. These elevated concentrations of dust were caused by street sweeping activities associated with offsite road construction in the vicinity of PAM-3. This dust was not associated with ground intrusive or impacted soil activities; therefore the site conditions remained at the operational condition (less than the Action Limit).
