Community Air Monitoring Program May 11, 2009 through May 16, 2009

Community air monitoring data is reviewed and compared to specific NYSDEC/NYSDOH approved criteria, known as "Action Limits". As a result of this evaluation process, site conditions are categorized into two categories, "Operational Condition" and "Action Condition". The "Operational Condition" is applicable when the data is below the "Action Limits" noted in the table below. The "Action Condition" occurs when one or more fifteen minute average measurement for Dust (PM₁₀), Total Volatile Organic Compounds (TVOC), Naphthalene or Odor Intensity exceeds the background or upwind measurement by the "Action Limits" in the table below. During the period between May 11, 2009 and May 16, 2009 there were three Portable Air Monitoring (PAM) locations measuring TVOC and PM₁₀ during normal work hours. The completion of ground intrusive or impacted soil activities at the Sag Harbor remediation site prompted the site activities to transition into the demobilization phase. At the beginning of the demobilization phase air monitoring for TVOC and PM₁₀ was reduced from six FAM locations to three PAM locations. **Fifteen-minute averages for odor intensity, naphthalene, TVOC, and PM₁₀ data remained in Operational Condition**.
